## General terms and conditions

### CHAPTER 1 – GENERALITIES

#### FORMALITIES

The inscription becomes effective as soon as the attached booking form has been received. 30% of the total will be taken from your credit/debit card if you booked lodges or camping site for more than 20 nights. You have to send this form duly completed in order to validate your reservation.

#### ID CARD/DEPOSIT

The deposit asked to validate the booking represents 30% of the total. In case of cancellation or change of the participants' number, penalties might be kept according to the conditions specified in the section STAY CANCELLATION.

#### HIGH SEASON LOW SEASON

The periods of high and low seasons are defined by the campsite la Lône:  
 High season: June 1<sup>st</sup> to August 30<sup>th</sup>  
 Low season: from January to May and from September to December.

#### PRICES AND TOURIST TAX

The prices indicated are valid for the 2015 season. Our prices do not include the tourist tax. The amount of this tax is €0.20 per night per person.

#### DEPOSIT & INVENTORY OF FIXTURES

The total payment will be asked at the arrival. For the lodges, a deposit of €500 will be asked at your arrival but will not be cashed (except for more than one month rental). An inventory of place, furniture, material and kitchen utensils will be done the day of your arrival. You have to control all the anomalies thanks to the inventory form the day of your arrival and to warn the manager.

The deposit will be given back at most one week after the rental, after you have paid the rent and after the inventory has been done if no degradation has been noted.

After the inventory at the end of the rental and if they are any degradations, a part of the deposit could be given back, depending on the price of rehabilitation or replacement of the deteriorated material.

#### DEPARTURE

Before leaving, you have to check the general cleanliness of the lodges (cleaning products and brush are at your disposal).

Be sure all the lights and taps are off.

Turn off all the electrical devices.

Be sure all the exits and windows are locked.

Throw garbage in containers provided at the entrance of the campsite, the Espace Eaux Vives or the leisure base. Think about using the compost bins left at your disposal.

#### PERSONAL BELONGINGS

You are responsible for your valuable objects or personal belongings. The same is applicable to your vehicle.

#### ANIMALS

Pets, except those of 1<sup>st</sup> and 2<sup>nd</sup> categories, are accepted. They should be kept on leashes, tattooed and vaccinated against rabies, and their owner must remove dirt they cause. Be ready to show their vaccination record that will be asked at your arrival. Pets are under the responsibility of their owner and must not be left alone in the accommodation.

#### CAPACITY

The present quote is established for a maximum capacity of persons. If the number of holidaymakers exceeds the total capacity, the manager can refuse the additional customers. Any modification or contract breach will be considered at the customer's initiative.

#### INSURANCE

You are financially responsible for any degradation you could cause. You are responsible for any incident or accident that may occur as a result of non-compliance to the establishments' rules and regulation.

You therefore have to be insured with a contract such as a liability insurance.

### CHAPTER 2 – SHARED HOUSE MAISON DE LA LÔNE

#### ACCESS

The rooms and studios are available **from 4 pm** and must be left **at most for noon**. They are at your disposal in perfect state of cleanliness. During your stay, you have to maintain them clean. The accommodation should be left clean, if it is not the case, the price of rehabilitation will be charged.

It is forbidden to smoke in the enclosure of the shared house.

As this shared house may be used by several groups, it is asked to each one to respect the quiet and peaceful nature of the house and the community life.

### CHAPTER 3 – STAY CANCELLATION

#### By you:

Any cancellation will be notified by mail or email as soon as possible.

Whatever the purpose is, the campsite la Lône will keep a part of the deposit and will charge fees depending on the cancellation date or the number of people's reduction.

#### By the campsite:

In case of an external event independent of its will, the campsite reserves the right to modify the deliveries or to cancel the stays. In this case, the customer will have the opportunity to cancel his stay without the cancellation conditions to be applied. The deposit for the stay will be paid back totally.
